



## **TUITION RATES for Programs: Effective March 1, 2025 (Revised June 30, 2025)**

This tuition sheet is primarily for families that do NOT qualify for Child Care Financial Assistance (CCFAP). For these families the out of pocket tuition will be the “Non CCFAP Tuition” set out in the tables on this tuition sheet.

**Families who do qualify for CCFAP will hold an active certificate and will find their “family share” (tuition) on the certificate they receive from the Child Development Division.** This family share will be invoiced on a monthly or quarterly basis on **the 1st of each month/quarter**. For monthly payors this is calculated as 1/12th of the 12 month total family share based on their existing certificate. For example, if the family share is \$150/week the monthly charge will be calculated as  $\$150 \times \frac{52}{12} = \$650$ /month and this would be collected on 1st of each month *in advance* starting upon the date of enrollment. For quarterly payors, the amount is 13 x the weekly share, there being 13 weeks in a calendar quarter. Families with CCFAP certificates are not eligible for the discounts set out in the Tuition Tables below.

**We require all families to enroll in Bank Direct Debit (ACH) and do not accept credit cards. All tuition is due in advance of month/quarter of attendance. We do not offer weekly billing.**

- We apply a 5% discount for non-CCFAP quarterly payment plans. Quarterly payments are due on March 1, June 1, September 1 and December 1.
- We offer a 10% sibling discount off the lowest tuition for non CCFAP recipients only.
- We have a one time, non-refundable, registration fee of \$80 per family for all newly registered families. This fee is waived upon registration of a subsequent child.
- We require a creditable deposit equal to  $\frac{1}{2}$  month for monthly tuition payments and  $\frac{1}{2}$  quarter for quarterly tuition payments for newly registered families, or for families changing tuition payment schedule from monthly to quarterly. If a CCFAP certificate is active at the time of registration then the required deposit will be equal to  $\frac{1}{2} \times$  Family Share monthly contribution (as calculated above). If a CCFAP certificate is obtained after registration, the deposit already paid will be reduced to  $\frac{1}{2} \times$  Family Share monthly contribution and any remaining credit balance will be applied.
- A “Non-CCFAP” family is a family who is not eligible for the CCFAP program as of the date of billing and subject to our regular tuition. They have the option of a discounted quarterly payment plan and are also eligible for the “Non-CCFAP” reductions set out in the Tuition Tables below.

### **Infant & Toddler Program (6 weeks – to Sept 1 after 3rd Birthday)**

Only Full Time enrollment is available in the Infant-Toddler program (age 0-3). Birth to Three rates will apply until the child qualifies for Act 166 funding, that is, on September 1st after the child turns 3 years old, irrespective of enrollment or attendance in a 3-5 year room.

### Preschool Program (3 to 5 years) – Full Day Program

Act 166 (Public PreK) funding of \$3,982 for 2025/26 will cover 10 hours per week for all preschoolers who will be aged 3, 4 or 5 on or before September 1, 2025. This will automatically be applied during the school district year i.e. Monthly – 10 months, Quarterly – 3 Quarters. For the remaining period (June/July 1-Aug 31) an equal discount will be applied to provide a FLAT RATE billing structure and enable families to budget through the calendar year. **If the family is not eligible for Act 166 the full tuition rate will be charged before any deductions or CCFAP is applied.**

### Preschool Program (3 to 5 years) – AM Part Day Program School Year 2025/26

We require a one-time **returnable** deposit of \$300 and a **non-returnable** registration fee of \$80 upon registration for our Part Day program of 11 hours per week.

Minimum enrollment of 3-half days(minimum of 11 hours/week) - No “out of pocket” tuition charge to families.

**Act 166 credits of \$3,982 will cover the Tuition for 10 hours/wk of our 35-week program** for children who will be age 3 on or before September 1, 2025. This program follows the CVSD (Champlain Valley School District) school calendar.

If applicable, our program will charge a CCFAP qualified family the **lower** of the Non CCFAP tuition and the amount of Family Share on their certificate.

For those families whose child is not yet age eligible and does not qualify for Act 166 funding, the tuition will be **\$398.20/month** for enrolling **3 half days/week**, **\$592.20/month** for enrolling **4 half days/week** and **\$714/month** for **5 half days/week**.



### **School Age Program (5 - 8 years) – School Year 2025/26 (limited to 22 participants)**

**Treehouse rates (Grades K-3)** for the Summer 2025 season **will be \$780/session(2 weeks).** Registration will begin on or before **2/15/2025.**

Our “junior” camp, **Sugar Maples** for rising Kindergartners will be charged at the regular Preschool Tuition of **\$1500/month.** Registration will begin on or before **3/15/2025.**
